



MEAN SAT Scores Compared to College Readiness Benchmarks








Comments: The data above illustrates Arbor Preparatory High Schools' performance on the Reading and Writing and Math portions of the 2015-16 SAT test. The results are displayed in both table and chart form and provide Arbor Preparatory High School 2015-16 data compared to the 2015-16 Washtenaw ISD's and the 2015-16 State's. The data highlighted in green indicates areas where Arbor Preparatory percentages of students proficient are higher than the State proficiency rates and where Arbor Preparatory average(MEAN) scores exceeded the College Readiness Benchmark. Data highlighted in red indicates an average score lower than the benchmark.


Arbor Preparatory High School was unranked on the last published Top to Bottom List (for the 2013-14 school year). The academy was not on the recently released bottom 5th percentile group for 2014-15. Sometime later this fall the State will release the rankings based on the above 2015-16 testing.






Comments: The data above illustrates Arbor Preparatory High Schools's 2015-16 performance on the Reading and Math Northwest Evaluation Association's Measure of Adequate Progress (NWEA/MAP). The charter contract measures school growth using this assessment, setting the goal of at least 50% of students reaching their growth targets. The graphs above show that students at Arbor Preparatory High School are, on average ("School Average") meeting their reading and math growth targets as well as the grade-level achievement targets.

Quadrant charts on the next page further illustrate the growth and achievement levels of the students at Arbor Preparatory High School. The markers on the charts represent the other schools that Bay Mills Community College charters. The quadrant illustrations can be used to compare Arbor Preparatory High School with other schools authorized by Bay Mills Community College.
