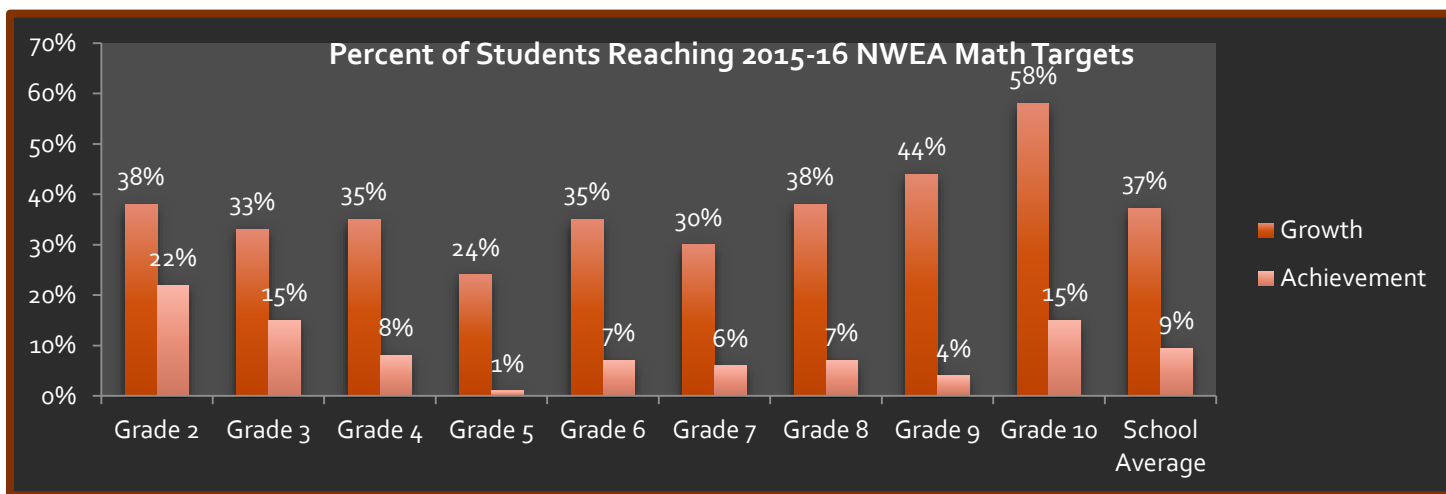
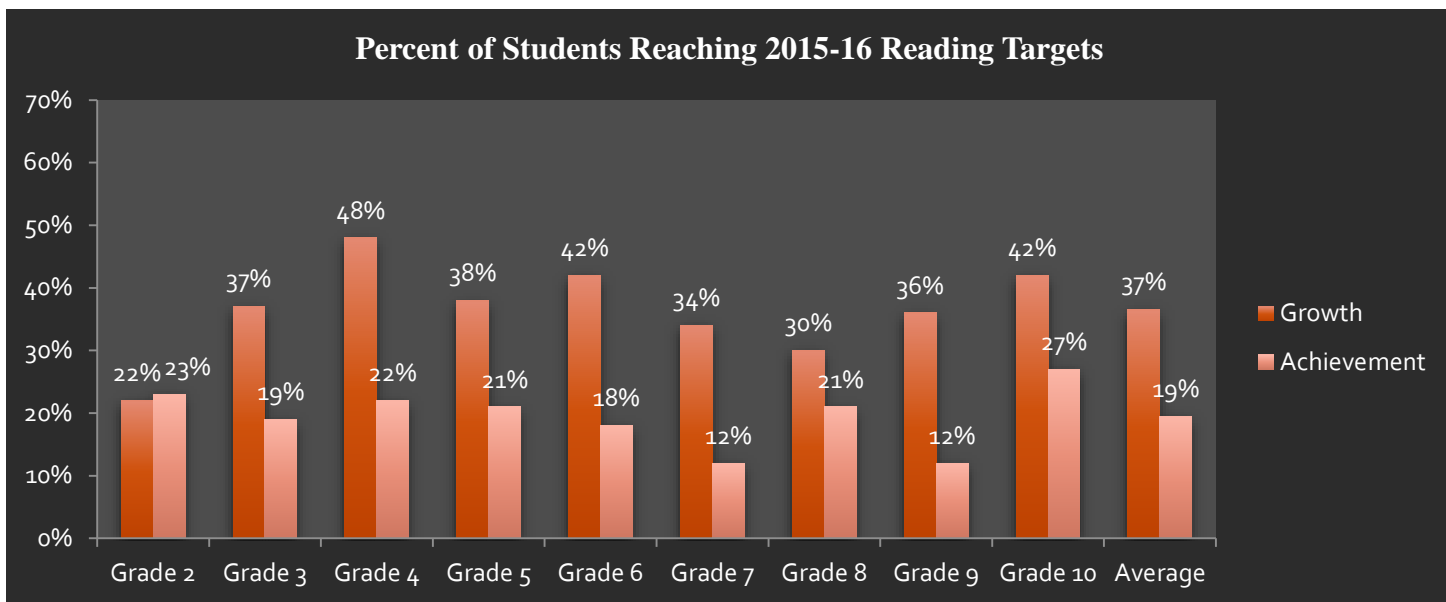




Comments: The data above illustrates Bradford Academy’s performance on the English Language Arts (ELA) and Math portions of the 2015-16 Michigan Student Test of Educational Progress (M-STEP). The results are displayed in both table and chart form and provide Bradford Academy 2015-16 data compared to the 2015-16 Oakland School’s, the 2015-16 State’s, and the academy’s 2014-15 results. The data highlighted in green on the above tables indicates an increase in proficiency rates from 2014-15 to 2015-16. The data highlighted in red indicates a decrease. Bradford Academy results were below the State results in all grades and in both math and ELA.

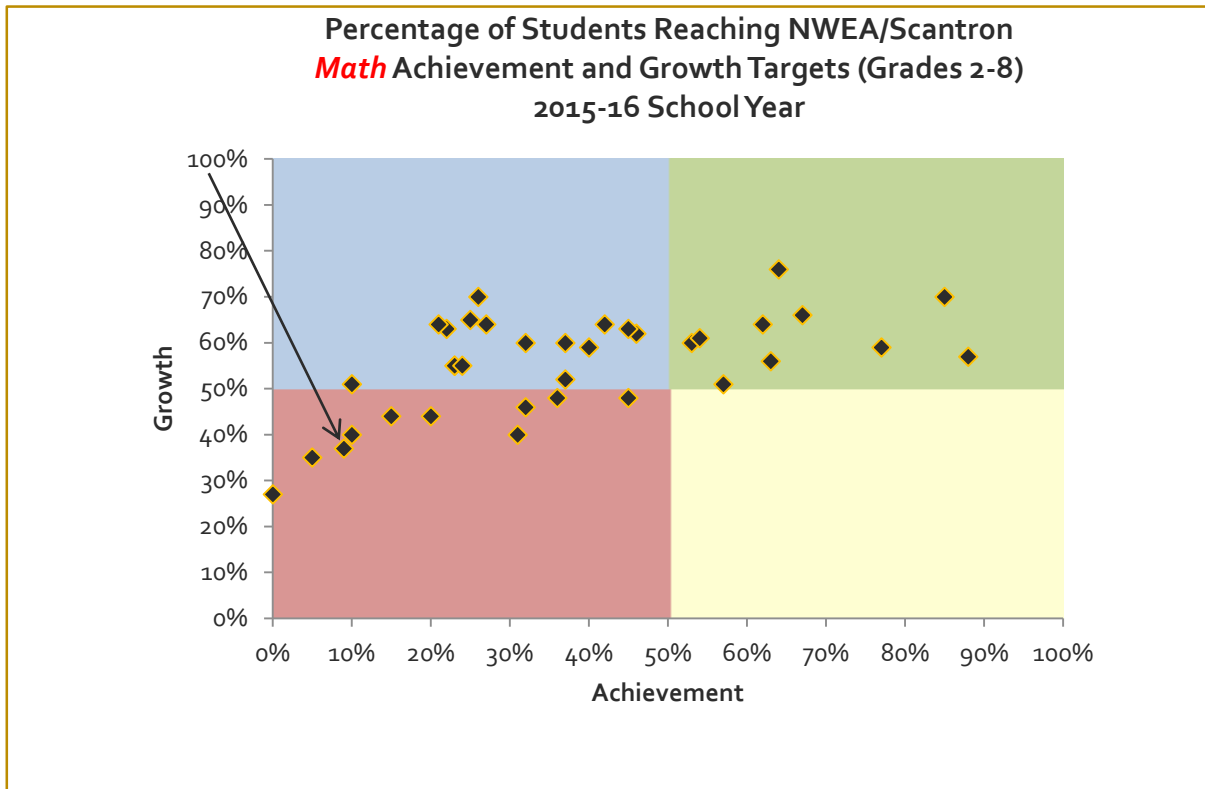
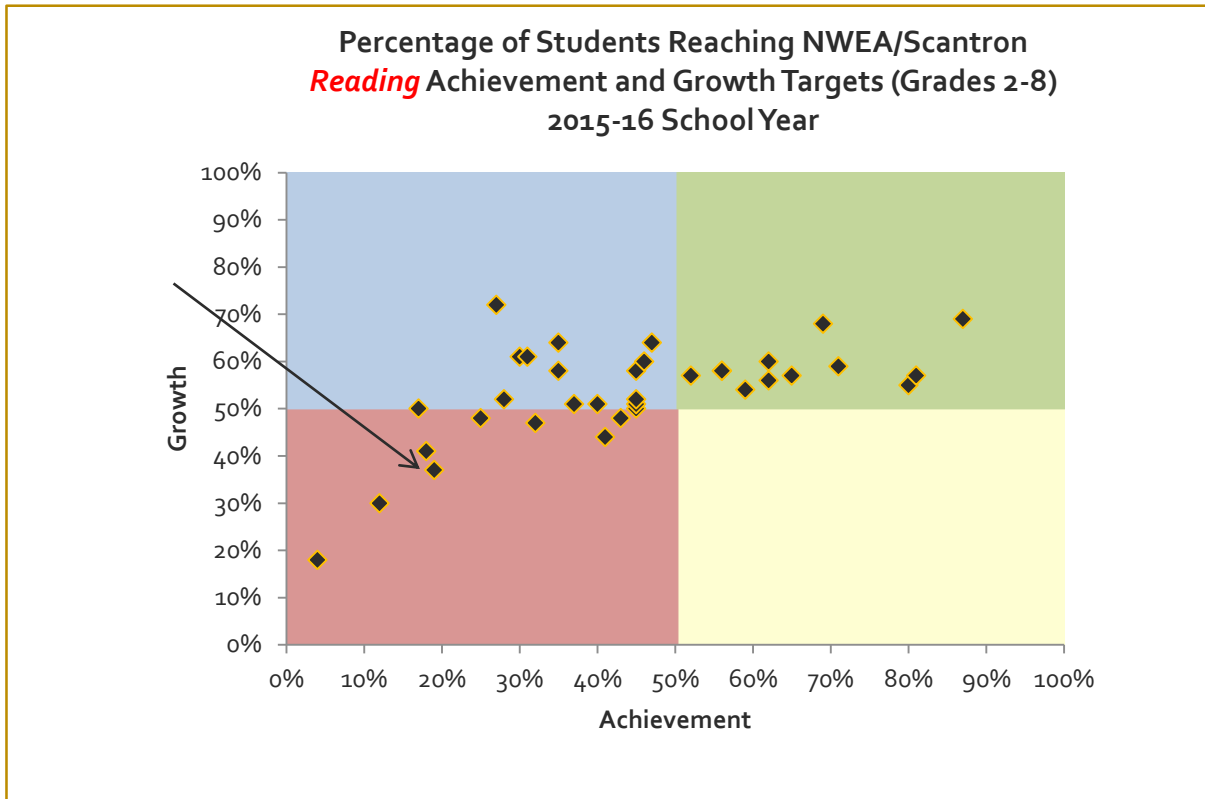
Also illustrated in the above charts are Bradford Academy’s SAT results compared to the ISD and to the State, and in a separate chart the average (MEAN) academy score compared to the SAT College Readiness Benchmarks for Reading and Writing and Math. On average, Bradford Academy students scored below the College Readiness Benchmarks.

Bradford Academy was ranked in the 39th percentile on the last published Top to Bottom List (for the 2013-14 school year). The academy was not on the recently released bottom 5th percentile group for 2014-15. Sometime later this fall the State will release the rankings based on the above 2015-16 testing data.



Comments: The data above illustrates Bradford Academy’s 2015-16 performance on the Reading and Math Northwest Evaluation Association’s Measure of Adequate Progress (NWEA/MAP). The charter contract measures school growth using this assessment, setting the goal of at least 50% of students reaching their growth targets. The graphs above show that students at Bradford Academy are, on average (“School Average”), not meeting their reading and math growth targets. The students at Bradford Academy are, on average, not meeting their math and reading grade-level achievement targets using this assessment.

Quadrant charts on the next page further illustrate the growth and achievement levels of the students at Bradford Academy. The markers on the charts represent the other schools that Bay Mills Community College charters. The quadrant illustrations can be used to compare Bradford Academy with other schools authorized by Bay Mills Community College.
