ADDENDUM TO LEASE AGREEMENT

This Addendum to Lease Agreement ("Addendum") is made by and between **PORTAGE TOWNSHIP** ("Lessor") and **THREE LAKES ACADEMY** ("Lessee") (individually, a "Party" and collectively, the "Parties").
